

## Weekly report on share repurchases

In the context of the share repurchase programme of Galp Energia SGPS, SA's ordinary shares with the purpose to reduce the issued share capital, the Company informs about the transactions occurred during the period from 13 June 2022 to 17 June 2022 (inclusive).

According to the information provided by the intermediary appointed to make the purchases, Galp has acquired shares in Euronext Lisbon regulated market, as detailed in the table below (aggregated information):
