Introduction

Over the past few decades, there has been growing concern about global warming and its inevitable consequences.

The last decade was particularly marked by decisions for sustainable development, namely with the negotiation and signing of the Paris Agreement in 2015, which aims to decarbonise the world's economies and limit the rise in global average temperature below 2°C compared to preindustrial levels, and with the definition, in the same year, of the United Nations Sustainable Development Goals (SDGs). The Paris Agreement, ratified by 195 States, also propelled the well-known European Green Deal in 2019, which establishes a set of European Commission policies and strategies and gave rise, more recently, to the European Climate Law.

Galp recognises that climate change is one of the most important global challenges and has established a clear purpose: "Let's regenerate the future together".

Our priorities are to regenerate the portfolio of energy we produce and sell, refresh our relationship with Society and reenergise our People.

By 2030, Galp will have reorganised its energy profile, which will be more focused on low carbon, having established solid foundations to continue investing in a sustainable growth.

The energy transition depends on everyone's commitment. Galp, as a fundamental pillar in the economy, intends to prosper during this transition, growing through one of the most efficient portfolios in the sector and aspiring to be at the forefront of our future. To accelerate our decarbonisation and achieve our ambition of net zero by 2050, we will expand our renewable energy business and our position in the value chain of electricity and new energies.



Our approach to climate change

We recognise the importance of changes in the energy system and aim to play an active role in this transition, while responding to climate challenges.

Our commitment to sustainable development is reflected in our decarbonisation ambitions, aligned with our strategic plan:

- Reduction of 40%¹ of absolute emissions from operations (scope 1 and 2) in 2030;
- Reduction of 40%¹ of the production carbon intensity in 2030;
- Reduction of 30%¹ of all downstream sales carbon intensity in 2030.

These targets are part of Galp's ambition to achieve Net Zero Emissions (emissions of scopes 1, 2 and 3) by 2050 and are aligned with the premises made in Galp's strategic plan.

Galp's long-term targets to reduce carbon emissions will be achieved primarily by implementing our main strategic guidelines, namely, the transition from our current portfolio to a more electrified and diversified global portfolio.

We want to be leaders in our industry towards the sustainable future. Hence, our intention is to engage in a strong growth plan, both in traditional and new businesses, while decarbonising the products we produce and sell.

¹ All reductions refer to 2017 as the base year, the year Galp announced its portfolio diversification beyond Oil & Gas and which will be considered the base year for any analysis of the evolution of carbon intensity in the future.

At Galp, we participate in the climate debate

The focus on sustainability and the development of clean and affordable energy solutions leads us, as a company, to commit ourselves in this great climate debate.



Our involvement with industry associations

Industry associations play a key role in society, as players for the development of collaborative platforms and to promote the best practices in different sectors of activity.

At Galp, we believe that it is essential to understand the dynamic nature and context of the sustainable development and its current and future challenges.

Thus, Galp promotes corporate citizenship through its membership in several associations and relationship with various industry partners. As a result, Galp benefits from a network of cooperation and knowledge-sharing, allowing us to develop the highest standards of performance and to promote relevant debates, within and outside the organisation.

Additionally, Galp, jointly with Industry Associations, supports the development of strategies aligned with the international community's goals, mainly those regarding the energy transition and carbon neutrality.

As for future association memberships, Galp focuses its choice on a set of criteria aligned with the Paris Agreement and the European Climate Law in accordance with Galp's strategy for the decade 20-30.



Evaluation of industry associations' alignment with climate change

Goals

The fast transition to a sustainable development paradigm requires companies to reflect on the commitments they subscribe as well as on the decision to join and participate in associations. Accordingly, Galp carried out an analysis of its main associations regarding their climate positioning, in order to:

- Identify the industry associations aligned with Galp's Purpose, Vision, Mission and Values, with regard to sustainable development, and thus the Paris Agreement and the European Climate Law;
- Promote transparency about Galp's participation industry associations;
- Encourage a sense of commitment and engagement to the challenge of combating climate change.

Evaluation methodology

Following the analysis described above, Galp established a set of objective criteria that provides a fair evaluation of the associations.

A) Paris Agreement

- Support the long-term goal to hold the increase in global average temperature below 2°C;
- Support the development of mechanisms promoting sustainable development, such as promote or endorse measures to mitigate greenhouse gas emissions or other global emissions.


B) European Climate Law

- 1. Support the carbon neutrality by 2050 target;
- 2. Promotion of initiatives to reduce greenhouse gas emissions;
- 3. Promotion or support of energy transition and efficient use of energy;
- 4. Promotion or support of the use of renewable energy;
- 5. Promoting the use of new technologies for carbon capture, use and storage (CCUS);
- **6.** Adoption or support for the use of clean, safe, and connected mobility solutions;
- 7. Support transparent climate communication and reporting.

C) Galp's Purpose, Vision, Mission and Values

The associations were evaluated according to the criteria listed above by a multidisciplinary Galp team, as follows:

- Aligned: organisations aligned with most of the criteria of the Paris Agreement, the European Climate Law, as well as Galp's Purpose, Vision, Mission and Values.
- **Partially aligned:** organisations partially aligned with the criteria of the Paris Agreement and the European Climate Law, although they may not yet be fully aligned with Galp's Purpose, Vision, Mission and Values.
- **Misaligned:** organisations misaligned with at least two of the criteria of the Paris Agreement, five of the criteria of the European Climate Law, and not aligned with Galp's Purpose, Vision, Mission and Values.



The information in this report was gathered as a result of an extensive research of public information such as official websites, reports, publications, media, public statements, among

others. If the information required was not publicly available, the associations were directly contacted for further information.

Scope - Industry associations assessed

The industry associations described in this report were selected based on their relevance to Galp's business and strategy, as well as their active role in energy policy debates.

Twenty (20) organisations were selected and evaluated, whose geographical distribution is diverse, both nationally and internationally. These organisations represent about 80% of Galp's contribution in this scope (with around €1.7 m of total contributions paid in 2022).

Evaluation limitations

The opinions and conclusions expressed in this review are those of Galp. This report offers an objective, fair, and coherent evaluation, necessarily subject to interpretation and judgments of opinion.

Findings

Out of the twenty (20) associations analysed, we concluded that nineteen (19) are aligned, one (1) is partially aligned and none (O) are misaligned.

ABEP – Associação Brasileira de Empresas de E&P de Petróleo e Gás

(Galp's contribution in 2022: ≅ 269k€)

Description: ABEP - Brazilian Association of Oil and Gas Companies integrates the IBP - Brazilian Institute of Petroleum and aims to promote the development of a competitive, ethical, and socially responsible oil, natural gas, and biofuels industry.

Alignment: Partially aligned

Detail: ABEP was classified as partially aligned since it is broadly compliant with the objectives of the Paris Agreement but has not yet met all our Climate Action criteria. However, ABEP integrates IBP and this last one has been taking steps to meet the challenge of combating climate change. As such, Galp will continue to work actively with ABEP and IBP towards these goals.

ABEEólica – Associação Brasileira de Energia Eólica

Description: ABEEólica is a non-profit Brazilian entity, bringing together and representing the wind energy industry in Brazil, including companies from the entire production chain. The association has contributed effectively to the development and recognition of wind energy as a clean, renewable, low environmental impact, competitive and strategic source for the composition of the national energy matrix.

Alignment: Aligned

Detail: Association aligned with the objectives of the Paris Agreement and the European Climate Law, as well as with Galp's Purpose, Vision, Mission and Values.

ABSOLAR – Associação Brasileira de Energia Solar Fotovoltaica

Description: ABSOLAR is a non-profit Brazilian entity, bringing together companies from the entire value chain of the photovoltaic solar sector operating in Brazil. The association coordinates, represents and defends the interests of its members within the scope of market and sector development by promoting solar energy.

Description: ABA is a non-profit Portuguese entity with a fundamental concern: to promote bioenergy in the energy transition towards the circular economy. Description: The main goal of AOP - Spanish Association of Petroleum Products Operators is to secure the general interests of the associated companies, through the follow up of oil legislation and cooperation with the competent authorities in Spain.

APE- Associação Portuguesa da Energia

Description: The Portuguese Association of Energy (APE) is a non-governmental, non-profit and public utility institution, which aims to stimulate reflection and debate on the sustainable energy transition. APE is the national committee member of the World Energy Council (WE Council), an international organization in which Portugal has been represented since the 1930s.

Alignment: Aligned
